

ATTACHMENT TO ARTICLES OF INCORPORATION

Article 5. Other provisions:

5.1 Inurement of Income. No part of the net earnings of the Chapter shall inure to the benefit of, or be distributable to, any of its directors, officers, or other private persons, except that the Chapter shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

5.2 Dissolution. Upon the dissolution of the Chapter, the Board of Directors shall, after paying, satisfying, and discharging, or making provision for the payment, satisfaction and discharge, of all of the liabilities and obligations of the Chapter, and after returning, transferring, or conveying any assets held by the Chapter upon a condition requiring return, transfer, or conveyance by reason of the dissolution, transfer, convey, or otherwise distribute all of the assets of the Chapter to the Healthcare Financial Management Association, a not for profit corporation organized under the laws of the State of Illinois and qualifying as an exempt organization under § 501(c)(6) of the Internal Revenue Code of 1986, as amended (or corresponding provision of any future United States internal revenue law).
